# **Center for Population Health**

The Center for Population Health (CPH) is a main funding initiative of 1889 Foundation.

CPH's Community Care HUB (HUB) aims to impact health outcomes by addressing risk factors associated with poor health outcomes. The HUB partners with Care Coordination Agencies who hire Community Health Workers (CHWs) to meet participants face-to-face, preferably in their homes, and connect them with needed services such as employment, housing, transportation, and food.

Anyone can make a referral to the HUB including medical providers, social service providers, behavioral health providers, self-referrals, and more.

Additional CPH initiatives include:

• Social determinants of health initiatives around food security, housing, transportation, and more

- Addressing systems-level community health disparities including mental and oral health capacity
- Health data analysis including coordination of the Community Health Needs Assessment

• Education and community outreach around healthy living and activity

• Policy advocacy addressing community public health needs

# **Center for Population Health**

A major initiative of CPH is addressing food insecurity with a dedicated position. Local Food Systems Coordinator Nan McNinney has been working to advance local food systems through initiatives including:

- Developing food-related resource guides
- Expanding nutrition and education
- Addressing food insecurity
- Using food as an economic driver
- Promoting and expanding farmer's markets
- Exploring grants and best practice opportunities



The Women's Help Center and Community Help Center community garden projects have been major successes. The goal of both garden bed sites is to get the residents excited about growing food and maintaining the beds all while addressing food insecurity.



#### 1889 Foundation supports additional food initiatives, including:

#### Cambria County Backpack Program

This much needed and relied on program continues to expand to provide children with healthy and sustainable food options on the weekends. The most recent expansion in Ebensburg will be serving over 200 children in northern Cambria County. 1889 Foundation has provided ongoing funding for this program including \$20,000 in FY 2024.

#### Somerset County Mobile Food Bank

The mission of the Somerset County Mobile Food Bank centers around reducing the burden of travel for individuals seeking nutritious food options. By dispatching the mobile food truck to various smaller towns across Somerset County, SCMFB strives to minimize the distances people must travel to obtain essential groceries. 1889 Foundation provides funding for SCMFB through United Way.

#### <u>Sandyvale</u>

Each spring 1889 Foundation has provided \$5,000 in funding for Sandyvale's Greenhouse and Hydroponic System startup. This support enables Sandyvale's staff of volunteers to have the tools, materials, seeds, plant material and soil amenities to provide social service agencies in the community with free, fresh produce.

# Social Determinants of Health

#### Hosanna Industries

A \$500,000 grant to Hosanna Industries from 1889 Foundation is supporting free home repairs to owners in need through the Johnstown Resurrection Project. The goal is to preserve properties and prevent homes from becoming blighted.

The funds will be utilized to provide substantial housing repairs, rehabilitation, improvement and, when necessary, new construction.

Hosanna Industries works with Johnstown Redevelopment Authority to identify homeowners and properties with the highest need.

The 2024 grant will complete at least 25 home repairs in Johnstown.

## The Women's Help Center and Community Help Center

1889 Foundation granted \$200,000 to The Community Help Center (CHC), a division of The Women's Help Center (WHC), for continuing services to address, provide resources for, and, ultimately, prevent homelessness.

The CHC serves as the housing hub for Cambria County and connects those in need with essential housing services and resources. The essential services will provide adults and children with housing, food, connection to vital resources and medical care, and the support needed to obtain housing and regain their independence.

Currently, The CHC's emergency shelter program provides family-style shelter with 32 beds in a secure space, on-site at the main facility to women and their families.

For men or those who cannot be accommodated at the current facility, the organization worked to create the Shelter Contingency Program (SCP), which provides off-site shelter at hotels and other lodging. It also provides food and case management. Program participants work with a Housing and Resource Navigator to identify their housing needs, options, and facilitate their transition to permanent housing.

The Women's Help Center has experienced a growing need in the community for emergency shelter and housing resources.

In 2023, The WHC provided II,618 nights of shelter to adults and children experiencing homelessness. 386 individuals were in the emergency shelter and IOI of them were children.

# Social Determinants of Health

## Penn Highlands Center for Culinary Excellence

1889 Foundation provided \$96,000 to Pennsylvania Highlands Community College for equipment for the culinary education center and for the Supporting Scholars Fund to support culinary scholarships.

This grant funding aligns with several of 1889 Foundation's funding priorities including wellness and education. It will also be a way to assist the regional workforce through culinary education.

#### Johnstown Walk of Hope



1889 Foundation supported the Walk of Hope in both Johnstown and Somerset with a \$25,000 grant.

"We take pride in the fact that all donations stay in our local community, helping with the everyday needs that patients have," said Johnstown Walk of Hope Coordinator Marlene Singer.

Johnstown Walk of Hope is an allvolunteer, community-based nonprofit, which supports local cancer patients with their financial needs.

## **Equitable Hearing Initiative**

Many major healthcare insurances including Medicare and Medicaid do not cover the cost of hearing aids. Though, statistically, individuals who are 50 and older are significantly more likely to suffer from hearing loss, Medicaid will only fund the entire cost of hearing aids in children 21 and younger.

1889 Foundation granted \$20,000 to Easterseals Western and Central Pennsylvania (ESWCPA) to benefit the Equitable Hearing Health initiative.

Funding will provide up to six visits for hearing aids for income-qualified patients. The visits include hearing aid evaluation, hearing aid visits, and four follow-up support appointments.

# **Childhood Development**

#### **Forged Futures Initiative**

Formerly known as Safe Places, Forged Futures is a collaboration between nine community organizations providing programs at safe spaces for youth and young adults in the Cambria-Somerset Area.

The comprehensive set of programs serves a wide range of ages which allows each organization to focus on its target audience.

Through the collaboration, a series of overlapping programs provide positive role models, encourages strong character development, presents substance use and mental health interventions, physical activity and quality in-person interactions.



#### Hope 4 Johnstown

Supporting community events that promote health and wellness and provide resources and education on healthy living, especially when it comes to children and families is important to 1889 Foundation.

With that in mind, 1889 Foundation grants funds to Hope 4 Johnstown, a grassroots organization that aims to foster unity, safety, empowerment, and non-violence throughout Johnstown. Hope 4 Johnstown uses direct communication to positively impact Johnstown's most vulnerable neighborhoods through community block parties.

At the block parties, partner organizations set up tables with resource information. There are also kids' activities.

The community block parties create a safe place for families to gather, have fun, and take pride in their neighborhoods.

# **Childhood Development**

## **UPJ Communi-TEAMS**

During the 2023-24 school year, The University of Pittsburgh at Johnstown's Communi-TEAMS program partnered with

the Flood City Youth Fitness Academy and the Greater Johnstown Middle School, providing a total of 4 themed educational programs (Sustainability, Festive Fall, Sports & Health, and STEM).

Their capacity was expanded to accommodate the entire 7th grade from the middle school (Estimated 130 students).

1889 Foundation supports UPJ Communi-TEAMS through a multi-year grant.



#### Early Childhood Initiative

Providing a systems-wide coordinated approach to have all Cambria and Somerset County children in grade three at or above the Pennsylvania reading level standard by 2030 is the primary objective of the Early Childhood Initiative (ECI), as this achievement level is a marker of future academic, health, social and employment success.

The ECI was created through the collaborative efforts of the 1889 Foundation, Center for Population Health, Community Foundation for the Alleghenies (CFA), Lee Initiatives, United Way of the Southern Alleghenies, and Vision Together 2025. ECI has a mission of meeting the educational, health, and social needs of the youngest, most vulnerable residents (birth to age 8) across Cambria and Somerset Counties.

ECI's mission was built around the Five Freedoms for America's Children Framework – Freedom to be healthy, freedom to be economically secure, freedom to learn, freedom from hunger, and freedom from harm – to address issues impacting children.

To help facilitate the initiative, Lauren Lazzari was hired in January of 2024 under the United Way of the Southern Alleghenies. Funding is being provided by 1889, CFA, Lee Initiatives, and the United Way. Lazzari was hired to oversee the implementation of the ECI strategic plan for Cambria and Somerset counties.

## Color Rap

Through the Color Rap Literacy project, a reading book and activity book is provided to every child in kindergarten in Cambria and Somerset Counties. Besides reading, Color Rap books engage children in dance and song both in and out of the classroom. The Project also includes a 12-step curriculum resource for teachers in the classroom and parents outside the classroom to help them engage in their child's education. Funding for this initiative is provided through the Ann Harris Smith Foundation.



## Children's Aid Home Programs

Funding from 1889 Foundation to the Children's Aid Home of Somerset County, Inc. for its Family Foster Care Program provides services for infants to age 21 by providing a temporary living environment for children who have been removed from their home. It reimburses for room, board, and clothes, training and support, 24-hour on-call caseworker in emergency situations, and respite care. In turn, the foster parent provides a stable home environment, emotional support, clothing, healthcare, and transportation.

# Mental, Behavioral, and Physical Health

#### Learning Lamp

The Learning Lamp's Early Childhood Behavioral Interventions and Supports initiative uses master's level Early Childhood Mental Health Consultants to observe a child's challenging behavior and determine best practice to mitigate the behavior.

With ongoing support from 1889 foundation, The Learning Lamp can provide continuous behavioral health consultation and will be able to expand services to Shared Services member providers.

The Learning Lamp and their Shared Services partners will be able to avoid expelling or suspending students with serious behavioral and social emotional issues by implementing strategies proven to curb these behaviors.

#### **Project Echo**

1889 Foundation supported the Cambria-Somerset Mental Health Consortium's Psychiatry/Behavioral Health ECHO. The Consortium worked in collaboration with Penn State College of Medicine on the Project ECHO (Extension of Community Healthcare Outcomes) series. Project ECHO is internationally recognized and is an evidence-based approach to continuing education and tele-mentoring that leverages the power of sharing knowledge across miles and across disciplines.

"We have a subject matter expert and a room full of attendees representing a multitude of fields and disciplines, working together to identify best practices and resources," said Center for Population Health Associate Director Kimberly Roberts. "Truly an experience I have walked away from with enhanced knowledge that I can apply in my work."

The goal of the series is to further increase the knowledge and resources needed for local practitioners to meet the needs of patients with behavioral health disorders.

## Creative Health Impact Grant

The 1889 Foundation Creative Health Impact Grants, which is managed by the Pennsylvania Rural Arts Alliance (PRAA) are focused on fostering connections between the arts and the health and wellness of residents in Cambria and Somerset Counties.

The grant offers opportunities for local nonprofit organizations that have arts and health and wellness initiatives to apply for funding to support those initiatives. The grant requires a strong arts component with an equally strong health/wellness component.

## Beginnings, Inc. **Employee Care Program**

1889 Foundation is supporting several initiatives through Beginnings, Inc.

Safe Start Kids allows Beginnings to continue as a Cribs for Kids area partner. It also provides funding for additional safety items for families with newborns and babies.

**Beginnings Bookworms Family Libraries allows** participating families to receive a bundle of books focused on social-emotional learning.

The Beginnings Employee Care program is an innovative pilot model Employee Assistance Program. Education includes a retreat where employees learn how to address vicarious trauma, ways to build resilience, recharge and care for your brain before/during/after adverse experiences in the field.

## Second Chance 5K Run/Walk

Second Chance Fundraising was formed in March 2016 by Craig Smith after he was the recipient of a lifesaving heart transplant. Second Chance Fundraising's mission is to raise funds for organ, tissue, and cornea donation awareness initiatives in the Western Pennsylvania region. Funds also provide scholarships to college students through S.O.D.A. (Student Organ Donation Advocates) who are doing organ and tissue donation awareness in their communities. 1889 Foundation is proud to support Second Chance Fundraising as an organization supporting not only a healthy lifestyle through running and walking, but also their tireless efforts to raise organ donation awareness and education.

## Variety the Children's Charity

1889 Foundation provided funds to Variety the Children's Charity for its My Bike and My Stroller programs. Supporting Variety means supporting children and families in Cambria and Somerset counties who need safe bicycles and strollers to engage in healthy activities.

My Bike and My Stroller provide eligible children with disabilities with an adaptive bike or stroller, so they may have the opportunity to feel proud, to find greater independence and inclusion, and to create lasting memories with their family and friends in the community.

# **Medical Education and Training**

### Stop the Bleed trainings



Stop the Bleed has been a collaborative effort of the 1889 Foundation and Conemaugh's Trauma Services since 2017. The program was provided to at risk populations and areas with the initial focus being school districts. The program has since advanced to other high risk areas, namely churches, industry, social and community organizations and emergency responders. Research has shown that the quicker bleeding is controlled, the higher the survival rate.

Since the beginning, Tom Causer, RN BSN, RRT, HP; Trauma Coordinator, Trauma Services has been the lead instructor. The program is offered to any group at no cost and equipment is placed in high risk areas. 1889 Foundation funds the equipment (Stop the Bleed kit) that is provided after the program has been successfully completed by attendees. The program has also received support from American Trauma Society of Pennsylvania in collaboration with 1889 Foundation and Trauma Services.

In the 8 years since the program was established, it is estimated that over 1000 programs have been completed with over 18,000 individuals trained and over 3,300 Stop the Bleed related equipment placed.

## Berlin Lions Club's CPR/AED Training

1889 Foundation granted \$20,000 to the Berlin PA Lions Club for Community CPR/AED Training and the purchase and distribution of AEDs.

Dedicated to advancing the health and safety of the region, 1889 Foundation views this initiative's potential to quick administration of defibrillation, which could increase survival rates from sudden cardiac arrests and other emergencies.
